

RESOLUTION**SETTING THE FEES REQUIRED UNDER TITLE 8 OF THE EUREKA COUNTY CODE KNOWN AS THE PLANNING COMMISSION ORDINANCE**



Due and payable at time set in Resolution

All application fees are due and owing at the time the application is filed with Public Works. Checks for the application fees must be payable to the Department of Public Works. The Recordation Fee will be due and owing on all maps that are approved by the Board of County Commissioners and payable to the County Recorder at the time of recordation. All fees collected are non-refundable. All other resolutions inconsistent with this fee schedule are hereby rescinded. If Nevada State Law modifies the fees listed in this Resolution, Nevada State Law prevails.
