PUBLIC HEARING FOR FISCAL YEAR 2016-2017 BUDGET & TAX RATES

Notice was given that the Eureka County Board of Commissioners would hold a public hearing on May 16, 2016, at 1:00 p.m., to finalize the budget and adopt tax rates for the fiscal year beginning July 1, 2016. The purpose of this public hearing is to receive opinions and comments from members of the public on the proposed Fiscal Year 2016-2017 budget and tax rates before final action is taken. Copies of the Tentative Budget can be obtained and/or inspected by the public at the offices of the County Comptroller, County Clerk, or County Commissioners.
