

EUREKA COUNTY FAIR

BULL RIDING & OLD WEST SADDLE BRONC SHOW BID FORM

This is an invitation to bid to provide a Bull Riding and Old West Saddle Bronc show at the Eureka County Fair on August 13, 2016.

Please use this invitation to submit your bid(s) and attach supplemental pages as necessary. Sealed bids will be received for furnishing services according to these instructions and specifications.

To be considered, this invitation to bid form must be completed in its entirety and **must be received by mail at the address listed below no later than 5:00p.m. local time on May 2, 2016**. The bids will be opened and read at the May 2015 Eureka County Fair Board Meeting.

The decision to accept a bid will depend on the quality of the bid, not necessarily on the lowest bid price. If your bid is accepted, your bid constitutes a binding contract and includes the specifications of this invitation to bid.

Bid Specifications:

1. The submitted bid must include transportation of the horses and bulls to and from the fairgrounds.
2. The submitted bid must include the price for the entirety of the show. This includes announcer, entertainer, secretaries, etc.
3. The time frame provided for the Bull Riding and Old West Saddle Bronc Show is from 6:00 p.m. to 9:00 p.m. on August 13, 2016.
4. The horses and bulls must arrive at the Eureka County fairgrounds between 1:00 p.m. and 4:00 p.m. on Saturday, August 13, 2016.
5. The horses and bulls must be removed from the Eureka County fairgrounds by 12:00 p.m. on Sunday, August 14, 2016.
6. All horses and bulls must be sound and healthy.
7. Bidder must provide their own staff to load and unload horses and bulls at the Eureka County fairgrounds.
8. Bidder must provide their own staff to handle the horses and bulls in the arena and chutes during the Bull Riding & Old West Saddle Bronc event.
9. Bidder must provide their own staff to feed and water horses and bulls during their time at the Eureka County fairgrounds.
10. The Eureka County Fair will provide hay for the horses and bulls. The submitted bid must include how much hay the Bidder will require to feed the horses and bulls during their time at the Eureka County fairgrounds.
