Call to Order

Anne Kniefel made a motion to approve the potential costs for the youth activities. Rebecca Glocknitzer seconded the motion. A vote was taken and motion was adopted(6-0).

Buckles and Designs: A short discussion of buckles and designs was brought up and Darla Baumann stated that she has been working with IFA on ordering buckles for the 2016 Eureka County Fair.

2016 Musician Band: Department Assistant, Crissy Hubbard has scheduled and booked Jones & Fischer for the 2016 Eureka County Fair music entertainment.
