

EUREKA JUSTICE COURT FEES EUREKA/BEOWAWE DEPARTMENTS

In accordance with **NRS 4.060**, the following fees will be imposed on Civil and Small claims filings:
Also in accordance with **NRS 4.065** an additional \$1 has been added to the Commencement of any Civil/Small Claims action or proceeding in the Justice's Court for credit to the State General fund.

A. On the commencement of any civil action or proceeding:

If the sum claimed does not exceed \$2,500	\$51.00
If the sum claimed exceeds \$2,500 but does not exceed \$5,000	\$101.00
If the sum claimed exceeds \$5,000 but does not exceed \$10,000	\$176.00
If the sum claimed exceeds \$10,000 but does not exceed \$15,000	\$251.00
Civil action for Unlawful Detainer pursuant to NRS 40.290 to 40.420	\$226.00
In all other civil actions	\$51.00

B. For the preparation and filing of a small claims action or proceeding:

If the sum claimed does not exceed \$1,000	\$46.00
If the sum claimed exceeds \$1,000 but does not exceed \$2,500	\$66.00
If the sum claimed exceeds \$2,500 but does not exceed \$5,000	\$86.00
If the sum claimed exceeds \$5,000 but does not exceed \$7,500	\$126.00
If the sum claimed exceeds \$7,500 but does not exceed \$10,000	\$176.00
For filing of an answer or Counterclaim	\$33.00

C. On the appearance of any defendant, or any number of defendants answering jointly, to be paid by the defendant(s) on filing the first paper in the action, or at the time of appearance:

In all civil actions	\$51.00
For every additional defendant, appearing separately	\$26.00

D. No fee may be charged where a defendant or defendants appear in response to an affidavit and order issued pursuant to the provisions of [chapter 73 of NRS](#).

For the filing of any paper in intervention	\$26.00
For issuance of any writ of attachment, garnishment or execution or any other writ designed to enforce any judgment of the court other than a writ of restitution	\$26.00
For the issuance of any writ of restitution	\$76.00
For filing a notice of appeal and appeal bonds (only one charge if filed at same time)	\$26.00
For issuing supersedes to a writ designed to enforce a judgment or order of the court	\$26.00
For preparation and transmittal of transcript and papers on appeal	\$26.00
For celebrating a marriage and returning the certificate to the county recorder	\$75.00
For entering judgment by confession	\$51.00
For preparing any copy of any record, proceeding or paper, for each page	\$.50
For each certificate of the clerk, under the seal of the court	\$3.00
For filing and acting upon each bail or property bond	\$50.00
For searching records or files in his office, for each year	\$1.00
